5.12 The Honorary Secretary shall within one month after the election of a Member of the Club (other than a Temporary Member) send to him notice of his election together with information on how to obtain a copy of the Rules of the Club.
5.14 Application for Joint Club Membership shall be made upon the appropriate form which shall be signed by the proposer, no seconder is required.

A Full or Club Member who elects to take Joint Club Membership for their partner may sign as their proposer.

### 7.7 At a Committee Meeting to be held during June in every year the

 Honorary Treasurer shall bring forward a list of the names of all members whose subscriptions have not been paid by the date of that meeting, and the Committee shall have power without further notice to remove from the list of members the name of any such member in default. A Full or Club Member who elects to take Joint Club Membership for their partner may sign as their proposer.
