

Proposed Changes to the Rules of Leander Club Limited to be agreed at the General Meeting on 25 June 2023

Amendments to the current Rules are shown in the revised wording below with single underlining in the case of additions and struck through in the case of deletions.

<p>5.3 Subject to Rule 5.4 a candidate for election as a Full Member shall be proposed and seconded by Full Members. A candidate for election as a Club Member may have as his proposer or his seconder (but not both) a Club Member. Application for membership shall be made upon the appropriate form which shall be signed by both the proposer and the seconder. Subject to Rule 5.9, completed election forms must be received by the Honorary Secretary at the Club House at least one month before the date of the Committee Meeting at which the election takes place.</p>	<p>5.3 Subject to Rule 5.4 a candidate for election as a Full Member shall be proposed and seconded by Full Members. A candidate for election as a Club Member may have a Club Member either as their proposer or their seconder (but not both). <u>A Joint Club Member may second (not propose) a candidate for Club Membership.</u> Application for membership shall be made upon the appropriate form which shall be signed by both the proposer and the seconder. Subject to Rule 5.9, completed election forms must be received by the Honorary Secretary at least 7 days before the date of the Committee Meeting at which the election takes place.</p>

<p>5.11 Subject to Rule 4.6, a Temporary Member shall be admitted for such period and upon such terms and conditions as the persons admitting him shall determine. <p>7.7 At a Committee Meeting to be held during June in every year the Honorary Treasurer shall bring forward a list of the names of all members whose subscriptions have not been paid by the date of that meeting, and the Committee shall have power without further notice to remove from the list of members the name of any such member in default. The Honorary Secretary shall ensure that the name of any member so removed from the members' list be forthwith posted on the Club notice board and remain so until the 31 July of that year, or until he shall have been reinstated as a member of the Club under Article 29.6, whichever shall be the sooner.</p>	<p>7.7 At a Committee Meeting to be held during June <u>April</u> in every year the Honorary Treasurer shall bring forward a list of the names of all members whose subscriptions have not been paid by the date of that meeting, and the Committee shall have power without further notice to remove from the list of members the name of any such member in default. The Honorary Secretary shall ensure that the name of any member so removed from the members' list be forthwith posted on the Club notice board and remain so until the 31 July of that year, or until he shall have been reinstated as a member of the Club under Article 29.6, whichever shall be the sooner.</p>
