

Proposed Changes to the Rules of Leander Club Limited to be agreed at the General Meeting on 22 June 2025

Amendments to the current Rules are shown in the revised wording below with single underlining in the case of additions and struck through in the case of deletions.

<p>Full Members and Club Members</p> <p>5.3 Subject to Rule 5.4 a candidate for election as a Full Member shall be proposed and seconded by Full Members. A candidate for election as a Club Member may have a Club Member either as their proposer or their seconder (but not both). A Joint Club Member may second (not propose) a candidate for Club membership. Application for membership shall be made upon the appropriate form which shall be signed by both the proposer and the seconder. Subject to Rule 5.9, completed election forms must be received by the Honorary Secretary at least 7 days before the date of the Committee Meeting at which the election takes place.</p>	<p>Full Members and Club Members</p> <p>5. .3 Subject to Rule 5.4 a candidate for election as a Full Member shall be proposed and seconded by Full Members. A candidate for election as a Club Member may have a Club Member either as their proposer or their seconder (but not both). A Joint Club Member may second (not propose) a candidate for Club membership. Application for membership shall be made upon the appropriate form which shall be signed by both the proposer and the seconder. <u>via the online application form on the Leander Club website.</u> Subject to Rule 5.9, completed election forms <u>electronic application forms</u> must be received by the Honorary Secretary <u>submitted</u> at least 7 days before the date of the Committee Meeting at which the election takes place.</p>

<p>Subscriptions</p> <p>7.3 Annual Subscriptions shall become due on the 1 January in each year in advance, and, except in the case of Members resident overseas who have no Bank account in the United Kingdom, shall be paid by Direct Debit to the Club's Bankers. The Committee may make arrangements to collect the Annual Subscription in instalments.</p>	<p>Subscriptions</p> <p>7.3 Annual Subscriptions shall become due on the 1 January in each year in advance. <u>Subscriptions shall be paid by Credit or Debit Card via the relevant online payment system and,</u> except in the case of Members resident overseas who have no Bank account in the United Kingdom, shall be paid by Direct Debit to the Club's Bankers.
